Program activities	<p>SDP site</p> <p>Taunggyi and Hopone</p> <ul style="list-style-type: none"> - Township mapping, Monthly data dashboard vinyl are present at SDP sites in Taunggyi and Hopone townships. - Presumptive TB referral and TB patients registers, TPT register, DOTs register are present at the SDP. - Volunteer referral, Patients Register and Summary sheets are also kept at the SDP in monthly basis according to security concern during this period and data safety in storage. - SDP rental cost- 500000 for Taunggyi and 250000 for Hopone until December 2024. <p>SCC</p> <ul style="list-style-type: none"> - Our volunteer had SCC site for sputum collection from nearby villages in purposed of easier transport sputum collection from coverage volunteers and sputum diagnosis at lab center. <p>Taunggyi</p> <ul style="list-style-type: none"> - SCC site is at Volunteer Nan Shwe Nu and she is collected sputum from nearby village site and transported to township hospital.

- She had copied of monthly sputum register and summary sheet up to February 24 and she has promo items about sputum collection and transportation such as ice box, sputum cups, pamphlets etc..

- SCC site is at Volunteer Nan Mya Htwe and she has collected sputum sample from nearby villages. Then, she had transported to township hospital lab center for sputum diagnosis. She had copies of monthly sputum register and summary sheet up to February 24. She has fully supported by promo items about sputum cups, ice box and pamphlets etc...

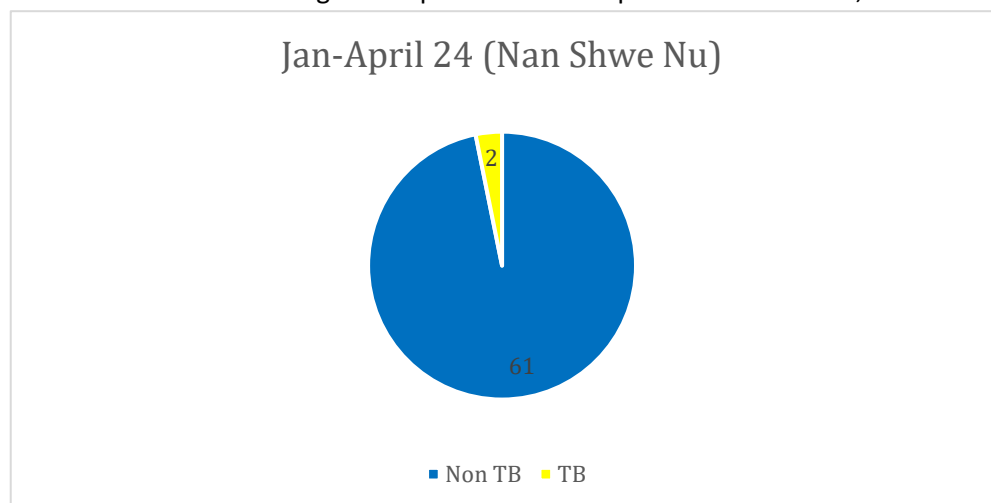

- We also had joint supervision with SCC supervision together by volunteer monitoring visit.

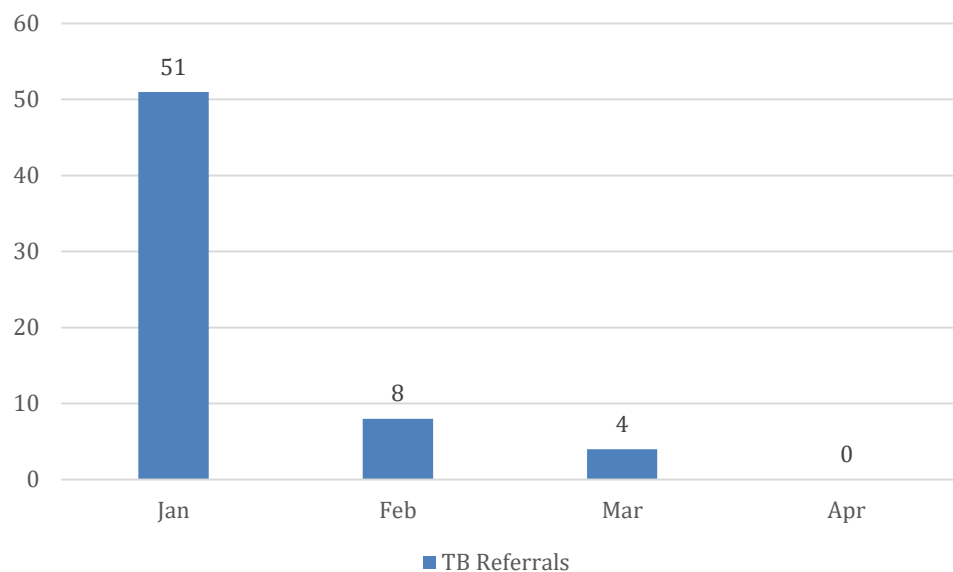
- Taunggyi

She has total referred 63 patients and new 2 TB patients up to April 24.

TB Suspected Referrals (Nan Shwe Nu)

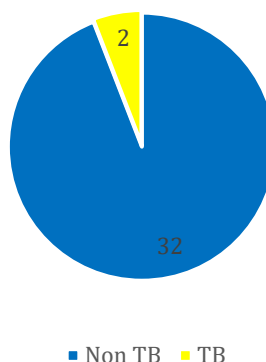


- Hopone

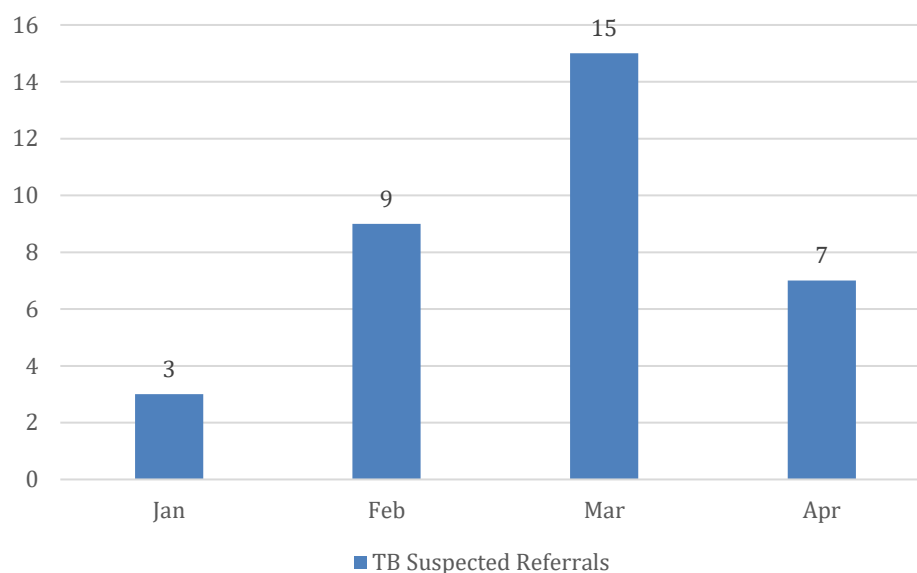

- Taunggyi

We had monitoring to a TB patient under Nan Shwe Nu's DOTs supervision. He had regular taking of medicine and no special complaints about side effects. His DOTs supervision card and DOTs app are also supervised by Nan Shwe Nu. She had regular visit to him.

- Hopone

We had monitoring to a TB patient under DOTs supervision of our volunteer. He has not special side effects and regular taking of medicine. His DOTs supervision card is also supervised in regular basis. His family member under 5year is also taking TPT.
